The Board of Township Trustees of Union Township, Miami County, Ohio met in regular session on the 28 day of August, 2017, at the offices of the Union Township Trustees with the following members present: Jim Albaugh, William O'Brien, and Philip Mote.

Trustee Albaugh moved the adoption of the following Resolution:

Resolution No - 17-06

A Resolution Indefinitely Prohibiting Licensed Medical Marijuana Cultivators, Processors and Retail Dispensaries Within The Unincorporated Territory Of Union Township, Miami County, Ohio

WHEREAS, effective September 8, 2016, Ohio Revised Code Chapter 3796 provides for the cultivation, processing, sale and use of medical marijuana within the State of Ohio; and

WHEREAS, Ohio Revised Code section 3796.29 authorizes the Board to adopt a resolution prohibiting licensed medical marijuana cultivators, processors and retail dispensaries within the unincorporated territory of Union Township, Miami County, Ohio.

NOW, THEREFORE BE IT RESOLVED by the Board of Trustees of Union Township, Miami County, Ohio that:

1. Cultivators of medical marijuana licensed pursuant to Ohio Revised Code section 3796.09 and activities permitted to a licensee under R.C. 3796.18, or any other manner of cultivation of medical marijuana authorized by Ohio Revised Code Chapter 3796, are hereby prohibited within the unincorporated territory of Union Township, Miami County, Ohio; and
2. Processors of medical marijuana licensed pursuant to Ohio Revised Code section 3796.09 and activities permitted to a licensee under R.C. 3796.19, or any other manner of processing of medical marijuana authorized by Ohio Revised Code Chapter 3796, are

hereby prohibited within the unincorporated territory of Union Township, Miami County, Ohio; and

3. Retail dispensaries of medical marijuana licensed pursuant to Ohio Revised Code section 3796.10 and activities permitted to a licensee under R.C. 3796.20, or any other manner of retail dispensing of medical marijuana authorized by Ohio Revised Code Chapter 3796, is hereby prohibited within the unincorporated territory of Union Township, Miami County, Ohio; and

BE IT FURTHER RESOLVED that this Resolution shall become effective immediately upon its adoption and shall continue in effect indefinitely unless terminated by action of the Board of Trustees of Union Township, Miami County, Ohio; and

BE IT FURTHER RESOLVED that the Fiscal Officer is hereby directed to post a copy of this resolution in the usual places where the Board posts public notices and to cause notice of this resolution to be published within a newspaper of general circulation within Union Township, Miami County, Ohio.
